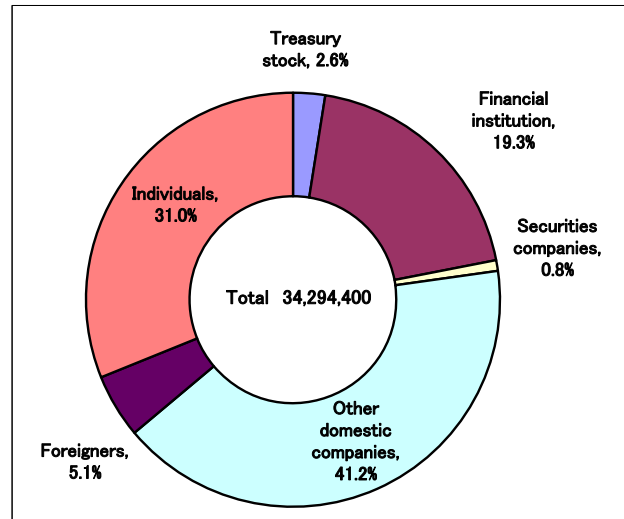

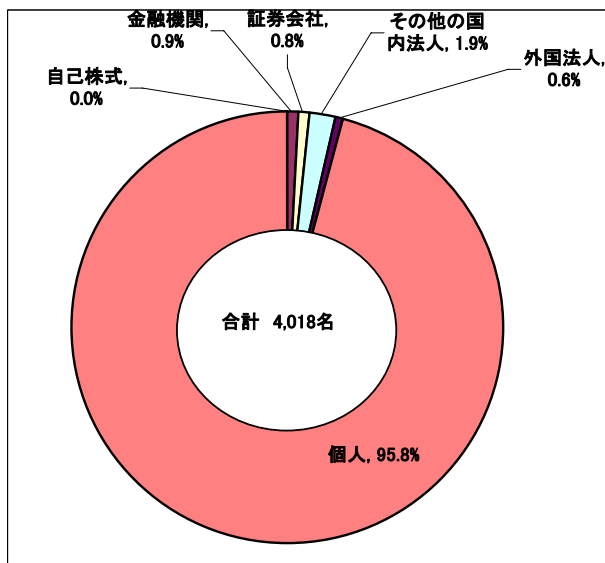

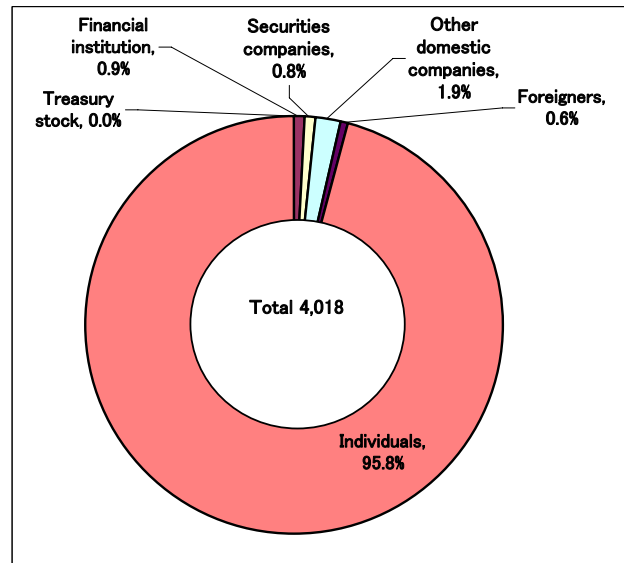
◆Stock distribution by owners



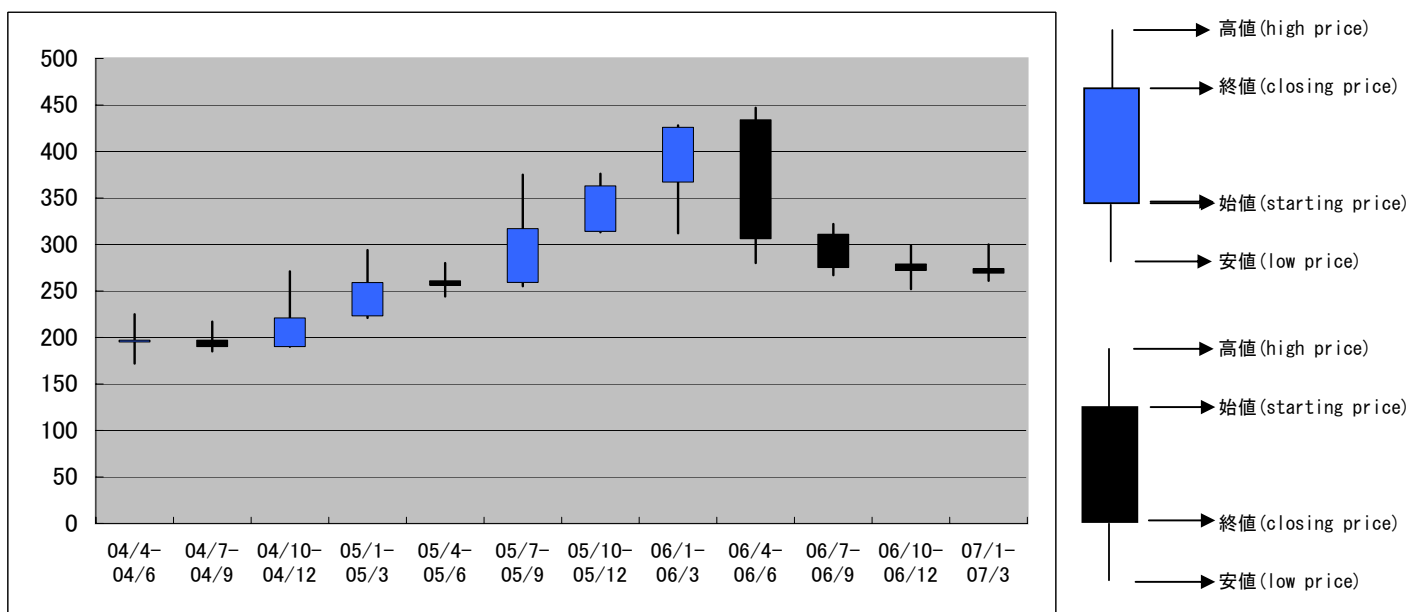
◆所有者別株主数
